

Defined Contribution Retirement Plan Options - Tax Sheltered Annuities (TSA)

- Defined Contribution Retirement Plan (DCRP) programs are available to all employees.
- Employees can participate in one 403 (b), one 457 plan and one Roth 403 (b)
- Employees must contact the vendor of their choice (listed below) directly for questions or information on their plans. Once contributing, employees must contact their agent to make contribution changes (increase, decrease, cancellations).
- A TSA Agreement must be completed and signed by employee & agent when enrolling or making changes. Each vendor will forward such changes to the payroll office for payroll deduction processing.
